Town and Country Planning Act 1990

Certificate of Lawfulness (Proposed) Granted

Reason for the Decision:

- The Single Storey rear extension infill to the side and replacement windows is permitted under Class A of Part 1 of the Town and Country Planning (General Permitted Development) (England) Order 2015.(as amended)
- The roof repair is permitted under Class B of Part 1 of the Town and Country Planning (General Permitted Development) (England) Order 2015.(as amended).

The walk on sky lights in the front roof slope are permitted under Class C of Part 1 of the Town and Country Planning (General Permitted Development) (England) Order 2015 (as amended).

Informative(s):

- The development would only constitute permitted development if the materials used in any exterior work to the single storey rear extension/roof subject to the grant of this certificate, shall be of similar appearance to those used in the construction of the exterior of the existing dwelling house, in accordance with Condition A.3/B.2 of the Town & Country Planning (General Permitted Development) Order 2015.(as amended)
- The development subject to the grant of this certificate would only constitute permitted development if the upper floor window/any window on/in the side elevation of the dwelling house is obscure-glazed and non-opening, unless the openable parts of the window are more than 1.7m above the floor of the room in which the window is installed}, in accordance with Condition A.3 of the Town & Country Planning (General Permitted Development) Order 2015.(as amended).
- This approval does not authorise the use of the public highway. Any requirement to use the public highway, such as for hoardings, temporary road closures and suspension of parking bays, will be subject to approval of relevant licence from the Council's Streetworks Authorisations & Compliance Team, 5 Pancras Square c/o Town Hall, Judd Street London WC1H 9JE (Tel. No 020 7974 4444). Licences and authorisations need to be sought in advance of proposed works. Where development is subject to a Construction Management Plan (through a requirement in a S106 agreement), no licence or authorisation will be granted until the Construction Management Plan is approved by the Council.
- Your proposals may be subject to control under the Building Regulations and/or the London Buildings Acts that cover aspects including fire and emergency escape, access and facilities for people with disabilities and sound insulation between dwellings. Noise from demolition and construction works is subject to control under the Control of Pollution Act 1974. You must carry out any building works that can be heard at the boundary of the site only between 08.00 and 18.00 hours Monday to Friday and 08.00 to 13.00 on Saturday and not at all on Sundays and Public Holidays. You must secure the approval of the Council's Noise and Licensing Enforcement Team prior to undertaking such activities outside these

hours.
