Whitebeam T1 - pronounced lean, which is getting worse over time. Reduce the crown of the tree by up to 4 metres and back most recent points of reduction. Reduce lowest limb on leaning side by a further 2 metres back to laterals branch break.
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
