Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

- 1 and 2. Acers: Prune by 3.5/5 metres to reduce the canopy size. They have grown too tall and crate too much shade
3. Eucalyptus: Fell to ground level and grind out stump. It is too big and project too much shade all year around; it is a non-native tree and it look incongruous in a conservation area such as Hampstead; the roots have extended in a radius of 10/15 meters - at least. They are growing all over under the easy lawn and have made the lawn so knobbly to the point that it is unsafe to walk on it for the elder owners of house, their guests, and children. The roots are extending in the neighbouring gardens and endangering their retaining walls, paths, and a magnificent stone pergola. The tree sheds so much foliage and barks that do not decompose and that suppress the growth of any other plant underneath. We propose to replace it with a mature deciduous tree such as *Betula utilis* (to match existing other 2 birches).
4. *Betula utilis* (n.2) Prune by 3.5/5 meters to reduce the size. Thi is to increase light in the flower beds underneath and in neighbouring gardens
5. *Taxus baccata*: Prune to reduce size by no more than 20% to give it a better shape and and increase light in the flower beds underneath and in neighbouring gardens
6. *Cedrus Atlantica*: Fell to ground level and grind out stump. it has been planted too close to the partition wall. Its trunk and roots will eventually compromise the wall and its branches are already extending too much into the neighbour's garden.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
