				<ul> <li>Disability scooter user concerned about remaining pavement space and safety (insufficient space for both the existing footpath and parking spaces)</li> <li>Removal of two bicycle stands, against policies in our local plan</li> <li>Removal of tree and impacting street amenity</li> </ul>
				Firstly, as a disability scooter user who uses this footpath on a daily basis, I have real cause for concern. The pavement in question, on Northington Street which is adjacent to 12/14 Northington street between John Street and Great James St, is a heavily used path. It serves the children of two nearby schools (St.George the Martyr & Christopher Hatton) as well as a main pedestrian path between Grays Inn Road and Lambs Conduit Street. With cars always parked in the metered and CAD parking spaces on Northington St, traffic is reduced to the single lane. With cars moving in both directions in that single lane, just next to the footpath, we need to be mindful of public safety and planning that affects it. This proposal only further increases risk as well as further concerns of cars driving up across the footpath. We need to ensure a duty of care, to ensure this footpath remains a safe area.
				Additionally, this proposal is of real concern as there is not enough space to park vehicles in the proposed area, and still pass safely and freely. The proposed parking space does not appear to be wide enough (note, no measurements provided in application) to ensure safe passage on the footpath. During November 2021, I noted that a small, compact silver Mercedes Benz was parked in front of 14 Northington street over the course of the month. Although the car was parked parallel to 14 Northington, almost touching the front elevation, that small car still projected out into the footpath. In fact, there was a very reduced, narrow passage created between the side of the car and the street-light. If a small car already projects onto the footpath, I am concerned of the impact of a mid-size or larger vehicle. As a disability scooter user, this has a real impact on my mobility in the area.
				Secondly, this application involves the removal of a tree which is currently beautifying a stretch of Northington street that has little street amenity. The removal of the tree would be a disservice to the public amenity.
				Lastly, the application requires removal of two bicycle stands. These stands are used daily. This feels very much against our community's sustainability and environmental goals – goals that we are all making sacrifices and working to achieve together.
