T1: Mulberry (7m): Crown reduce by 1-1.5m and remove major dead wood to reduce end weight and reduce risk of failure T2: Robinia (9m): Crown reduce by 1.5m to keep tree at a size suitable for its location T3: Robinia (10m): Crown reduce by 1.5m to keep tree at a size suitable for its location T5: Yew (4m): Fell as client wishes to replant deciduous species T6: Robinia (10m): Crown reduce by 1.5m to keep tree at a size suitable for its location and due to its close proximity to the property T7: Mulberry (7m): Crown reduce by 1.5m to reduce end weight and reduce risk of failure T8: Hawthorn (7m): Reduce back from road by 1.5m to stop encroachment over the roadway
