T1: Acer/Norway Maple: Approximately 9.00m. Reduce crown by approximately 1.50-2.00m all round. Thin crown density by approximately 20-25%. Remove dead wood throughout crown.
T2: Malus: Approximately 5.00m. Reduce crown by approximately 0.75-1.00m. Thin crown density by 20%. Remove dead wood throughout. Remove and recycle all branches through the house.
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
