My comment as follows:

As a resident in this area for over 30 years, and as a long serving member of the DPCAAC, the DPNF, a life member of the Heath & Hampstead Society, an active supporter of the Kentish Town City Farm, an active member of both Transition, Dartmout Park & Transition Kentish Town, Camden Think & Do, Camden Forest 2025 and many other local groups, I am writing to strongly object to the planning application for the following reasons:

The current proposals will not provide an acceptable housing mix as currently advised and required. for this part of the borough.

There is a need for 3 bed units, for sovial housing and affordable units- particulally in this area. The number proposed is higher that advised and the proposed pricing band unacceptably and clearly aimed at the investment, buy to let and short stay market. This will not meet the identified need in the area. It is already evident that over provision of one and two bed units for rental is leading to the closure of local primary schools and the fall in school rolls generally, as families are forced out.

The hight density and mass of many of the buildings is unacceptable, out of keeping with the context and will adversely affect important views in the area.

Views from the Heath and also from the surrounding conservation areas will be irreparably damaged and this must not be allowed to happen.

The 19 storey structures will cause wind tunnels and shade damaging to the environment, to the quality of life to wildlife and biodiversity and are out of keeping with the area and must not set a damaging precedent.

The roads, transport and other infrastruscture in the immediate and wider area is not sufficient for the increase in population and there is no extra space locally to provide the necessary infrastructure.

The proposal to make the so called green cooridor a popular cycle route, a walking route and a tranquil green space for residents without gardens is unrealistic and unachievable. Such a route will be dangerous for the disabled, for children and for residents.

The design is poor- given that there are excellent examples of low rise housing in Camden which support communities.

The proposals are outdates and do not respond or reflect recent changes in best practice for urban design when taking into account safety, security, biodiversity, green corridors.

This application should be withdrawn and the owners and developers should genuinly engage with the community to come up with a plan that genuinely serves the needs of this area now and for the future.
