Thank you for your letter/telephone call of 01 December 2021 giving notice that the above tree(s) are considered dead/dying /dangerous and require emergency works.

The Council confirms that the remedial works as described above are exempt from the need for further notifications or any formal application to the Council and you are therefore allowed to proceed.

Informative(s):

- 1 You are advised that the appropriate standards for tree work are set out in BS 3998: 2010. Failure to ensure that the proposed works are carried out to these standards may result in damage to the tree(s) and may result in legal action by the Council.
- Please note that any approval given by the Council does not give an exemption from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife. Conditions and Reasons:

Prior to the end of March 2022, a copper beech tree (Fagus sylvatica "Purpurea") shall be planted in the front garden of the property as a heavy standard with a stem circumference of 14-16cm at 1m above the rootball unless otherwise agreed with the council in writing. The tree shall be planted no less than 1m from any structure and in accordance with BS8545:2014 and no more than 2m from the boundary with the highway. Should the tree die or become seriously diseased within 5 years of planting it shall be replaced with a tree of the same species and size as detailed in this condition.

Reason: In order to comply with the provisions of Section 206 of the Town and Country Planning Act 1990 (as amended)
