## Identification of Tree(s) and Description of Works

T00202 (Oak) - Fell. This self-seeded Oak tree is not rooted at ground level and is causing damage to local graves. Due to it's proximity to the path and other listed graves, the tree needs to be removed to prevent further damage and to prevent it being a danger to the public.

T00204 (Oak) - Fell. This self-seeded Oak is causing damage to the graves which sit around it, causing their stones to move significantly and become dangerous.

In line with our Landscape Management plan, trees will be replanted.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
