## Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

Ash Tree (T0301) - Fell to ground level. This Ash tree is very poorly. The tree has a woodpecker hole and some rot which is all happening around halfway up the main trunk. This tree is approximately 4 metres away from the boundary fence and 6/7 metres from the Holly lodge building, with the potential of hitting the building and windows if it falls. The photos show the Holly Lodge buildings in the background. Due to the proximity to neighbouring buildings, as well as our own grave stones, we consider this a danger and so ask that it be considered under a 5 day notice. Replanting will take place in line with our Landscape Masterplan.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
