T1 (option two) Cherry Reduce all aspects of the crown by approx. 2.5 - 3 metres. Reduce the low limb over the road by approx. 3.5 - 4 metres. Lift low hanging branches to 4 metres above ground level. Thin by 10%. Remove all deadwood.
T2 Ash Fell tree in sections to ground level and treat stump with a herbicide to prevent regrowth.
T3 (option one) Ash Fell tree in sections to ground level and treat stump with a herbicide to prevent regrowth.
T4 (option one) Ash Fell tree in sections to ground level and treat stump with a herbice to prevent regrowth.
T5 Ash Reduce all aspects of the crown by approx. 2.5 - 3 metres. Remove Ivy. Remove deadwood

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
