Proposed Work:

REAR GARDEN: 1 x Sycamore (T6) - Crown lift to 4m from ground level ensuring minimum 2m clearance from building.

1 x Ash (T7) - Fell to ground level.

Group of Self-Sets (In area around T7) - Fell to 50mm from ground level.

1 x Ash (T8) - Crown lift to 4m from ground level to give minimum 2m clearance from building.

1 x Elders (T9 & T10) - Fell to 50mm from ground level.

1 x Ash (T11) - Fell to 50mm from ground level.

FRONT GARDEN: 2 x Ash (T12 & T13) - Crown lift to 4m from ground level

Group of Self-Sets (Along 30 linear metre right hand wall line) - Fell to 50mm from ground level, using MEWP.

- 2 x Ash (In front flower bed) Fell to 50mm from ground level.
- $1\ x$ Conifer (T14) Access via rope and harness techniques to face back rear of tree to give minimum clearance of 2m from the building.
- 1 x Evergreen Oak (T15) Crown lift to 4m from ground and crown reduce by approx. 2m to give minimum clearance of 2m from building.
- 1 x Narrow Leaf Ash (T16) Remove 3 x lower scaffold limbs which extend over main road to suitable cut points.

Group of Self-Sets (Left hand side of entrance road) - Fell to ground level.

The Council has considered your notification of intended works to trees dated 24 December 2021 and does not wish to object.
