NO OBJECTION TO SECTION 211 NOTICE OF WORKS TO TREE/S IN A CONSERVATION AREA

Proposed Work:

REAR GARDEN: 1 x Birch (T1) - Reduce crown by approx. 1m - 1.5m. Raise crown by up to 1.5m. Thin crown density by 20%.

1 x Birch (T2) - Remove weak and partially suppressed front stem. Raise crown by 1m. Reduce crown by approx. 1m - 1.5m. Thin crown density by 20%.

1 x Birch (T3) - Reduce crown by approx. 1m. Raise crown by approx. 1m. Thin crown density by 20%.

1 x Malus (T4) - Raise crown to main break. Thin crown density by 20%. Reduce extraneous branches back into main crown structure and tidy (approx. 30cm - 50cm).

1 x Sycamore (T5) - Remove 2 x developed basal suckers. Raise low limb over vegetable patch (growing towards house) by approx. 1.5m.

1 x Willow (T6) - Reduce lateral and sub lateral branch structure over lawn by approx. 1m - 2m.

1 x Holly (T7) - Trim to shape and tidy. Reduce crown by approx. 0.5m.

The Council has considered your notification of intended works to trees dated 02 February 2022 and does not wish to object.

Informative(s):

- 1 This notice is valid for 2 years from the date of this letter or until the work is completed, which ever is the sooner.
- 2 You are advised that the appropriate standards for tree work are set out in BS 3998: 2010. Failure to ensure that the proposed works are carried out to these standards may result in damage to the tree(s) and may result in legal action by the Council.
- 3 Please note that any approval given by the Council does not give an exemption from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife.
