20% via removal of suckering growth.  Remove ivy.			
T3. Sycamore (Acer psuedoplatanus)			
Rear garden rear boundary  Very large mature tree, previously reduced. To maintain cyclical pruning schedule and improve light into rear garden:			

Reduce canopy 1m beyond previous points of reduction (4-5m in height and 3m in lateral spread). Retain inner branch structure for crown continuity. Fell subdominant stem growing east to main stem union.
