Re-pollard thereafter on a triennial basis. You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.  - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
