Please identify the tree(s) and provide a full and clear specification of the works you want to carry out
Western Red Cedar at front of property: Remove to ground level. The tree was severely damaged during the Storm Eunice, losing 50% of its upper crown, leaving large tear wound approximately half way up the main stem. The remaining half of the upper crown is flat sided and top heavy above the wound leaving the tree vulnerable to further limb failure.
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
Where trees are protected by a Tree Preservation Order, please number them as shown in the First Schedule to the Tree Preservation Order where this is available. You should use the same numbering on your sketch plan (see below for sketch plan requirements).
