My name is Shiri Kraus and together with my business partner Amir Batito we own and manage our business <u>The Black Cow</u> - which is located in the Food Hall of Camden's Hawley Wharf.

We have been open since October and it would be fair to say we have struggled with the pandemic, low footfall and confusion over our hours of trading.

This variation will allow us to market to local residents and people visiting the cinema who cannot visit us as we close for service at 21:00.

This means we get no trade (walk up or reservations) beyond 20:00 as we have to ask people to leave!! In London this is a very harsh rule for us to abide by and deeply confusing for customers to understand.

Many of the Hawley Wharf residents say they do not understand why they do not have services on their doorstep at reasonable times in a place which is safe and secure and is not a nuisance in any way.

In late November and December the market allowed the use of TEN's to operate until normal restaurant hours and until Omricron arrived and everyone vanished we were encouraged by the take up of our extended offering.

There was no trouble, crime or violence during these TENs.

We need these hours as we need a level playing field with normal restaurants on the high street or we face financial peril.

We have tried everything and still we face an uncertain future.

We would face the future with a little more uncertainty if we were able to trade on a level playing field.
