Rear Garden:
G1: Hornbeam and hawthorn hedge line: approximately 8.00-10.00m. Reduce height up to approximately 1.50-2.00m. Reduce lateral and sub lateral growth overhanging rear boundary by approximately 1.50m. Reduce lateral and sub lateral overhang back from lawn of No.29 by approximately 1.50-2.00m. Remove dead wood throughout.
Right hand boundary:
T1: Mature Pear: Approximately 7.50m. Reduce back to previous and most recent reduction points, approximately 1.00-2.00m. Thin upper crown density by approximately 20%. Remove dead wood: General maintenance.
T2: Cherry Sapling: Approximately 8.00m. (Self sown) Reduce height by approximately 2.00m: To allow to regenerate a more open and

balanced crown structure.

T3: Mature Apple: Approximately 6.00-7.00m. Reduce crown back to previous and most recent reduction points. approximately 1.50m all round. Thin crown density by 20%. Remove dead wood throughout crown: General maintenance.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
