The basement floor has a rear patio, which is not accessible from the basement level. It has cement hard paving and a slope covered with weeds and grass, that makes for the difference in level between the street level rear garden and the level of the rear patio. Please refer to the drawings.

We are proposing the enlargement of this rear patio, and its connection to the basement level through patio doors. The floor of the rear patio will be finished in stone tiles and timber deck. There will be a retaining wall, made of bricks in an English Garden Bond fashion and a new staircase, clad with stone tiles, to give access to the garden. Please refer to drawings.
