Ash Tree (T1) To be felled to ground level. This Ash has fungal rot at base and a crack running though main trunk, making it dangerous and needing to be felled. Particularly due to the tree's proximity to the main path and listed monuments, we ask that this tree be considered under a 5 day notice as it is causing a danger to the public and graves. Replanting will take place in-line with our Landscape Masterplan.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
