Proposal:

IN COMMUNAL GARDENS/AREAS: 1 x Purple Cherry Plum (T3) - Fell to ground level. 1 x Sycamore (T5) - Fell to ground level.

1 x Lime (T6) - Reduce by around 4m back to previous topping points.

- 1 x Lime (T7) Fell to ground level.
- 1 x Sycamore (T16) Fell to ground level.

1 x Sycamore (T21) - Reduce upper crown by around 3m to lessen the load on the fork.

1 x Sycamore (T26) - Reduce upper crown by around 3m to lessen the load on the fork.

1 x Holm Oak (T27)- Prune growth over car park by around 2m and reshape as necessary.

1 x Lime (T48) - Removal basal growth.
