pruning points, allowing 0.5 metre clearance. Remove limbs in contact with fencing. Prune back from car
parking to paving slabs. T11: Sycamore (19m): Epicormic growth - Remove from stem. Due to close proximity, remove stem epicormics extending toward building

G33: Bay (G33): Lift low canopy - Specified extent. Prune up and away from car parking allowing 3 metre height clearance. Prune up and away from wall to clear by 0.5m
