The Pergola will have 8 ornate Victorian Metal supports, which will support the slopping Polycarbonate Roofing Sheet. Timber frame under roof to support roof and poles. The sides of the pergola will be enclosed with plastic curtain to provide additional weather shelter and insulation. Solar heating and lighting will hang from the timber beams. Additional plants and greenery will drape off the pergola to add to the aesthetic narrative. We want to propose a retractable awning extending from the existing boundary line to the start of the pergola to provide additional weather shelter.
