T1 Oak of the Site Visit, Background History and Recommendations document submitted.

Works: General overall reduction of height and spread radius of up to 1.5m, focussing on selective thinning and/or reduction of regen. regrowth from previous pruning stumps,

Combined with -

Selective lateral reduction of up to 2.5m targeting misshapen crown portions to the south, south-west, and north-east [see images] to balance crown.

Combined with -

Selective removal of duplicated previous pruning-stumps in order to form idealised scaffold limb structure [see images],

Combined with -

Selective removal of inner crown reactive epicormic growth – whilst ensuring inner crown natural-growth is retained as far as possible.

Reason: The above tree is considered to be responsible for root induced clay shrinkage subsidence damage to the subject property - Garden Flat, 37 Redington Road, London NW3 7QY. This application for ongoing management and pruning requirements for the subject following works carried out following Application Ref 2017/5546/T.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
