We are an art gallery and venue occupying a Grade 2 Listed former Victorian school building in Bloomsbury, Camden Council, London. Our property comprises an outdoor, internal courtyard with a metal staircase that provides access to the first and second floors. We would like to install a stairlift on the staircase to improve access for people with compromised mobility. The stairlift would require no permanent modifications to the building and would be fully removable. As there is no lift in the building, and no other stairlift, the proposal would help to address a current lack of Accessible access to the upper floors.
