T1- Cypress tree on left - (10m)- Cut to ground level.			
T2- Cypress tree (8m)- lightly prune back branches overhanging garden by up to 1.5 meters.			
T3- Lime tree- (20m) - Crown reduction back to most recent pruning points (up to 5m reduction).			
T4- Hawthorn tree (7m) with extensive decay and cavity in main trunk- remove to ground level.
