Installation of a public display of outdoor sculpture as part of Frieze Sculpture, sited in The English Gardens of The Regent's Park. This is a seasonal display taking place between September and November each year.

The displays will consist of up to twenty-four outdoor works of art. Excavation of existing ground may be required, subject to the nature of the proposed sculptures, including back-filling and re-turfing following installation and de-rig. Installation of the works will commence in early September and de-rig will be complete by end of November each year. The tenancy of the display will not exceed 90 days any year.

The maximum height of any art work in the display will be 12m. The width of depth of the works varies considerably, however, the largest anticipated footprint would be 15m x 15m.
