Tree number - G1 Tree type - 4x Cypress (x Cupressus leylandii) Approx Height - 12m Location - Right hand boundary, overhanging from neighbours Service - Prune Work required- Prune back overhanging growth by approx 1.5m Reason - To give clearance to roof and reduce debris/encroachment Tree number - G2 Tree type - 2x Sycamore (Acer pseudoplatanus) Approx Height - 16m Location - Rear garden, Right hand boundary Service - Crown thinning Work required- Thin crown by removing no more than 10% of live growth. Remove major deadwood over 40mm diameter and/or over 1m length and any broken/hanging branches (crown clean). Reason - as per clients specification, As part of regular maintenance Tree number - T1 Tree type - Sycamore (Acer pseudoplatanus) Approx Height - 16m Location - Rear garden, right hand side (in raised bed) Service - Dead wood Work required- Remove all deadwood over 40mm in diameter and/or 1m in length and any broken or hanging branches.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - $\circ\;$ marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
