Located in rear patio area:

London Plane T1 (28M high, 950mm dia.) - Raise canopy of the tree to crown beak at 10 metres above patio level. Reduce the lower crown spread up to 20 metres above patio level by drawing-in side laterals of the crown by up to 3 metres to create new reduction points.

Reason: Reduction of excessive shading as this is a large tree in a confined space that completely dominates the rear courtyard patio area and surrounding buildings causing severe loss of natural light.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

Where trees are protected by a Tree Preservation Order, please number them as shown in the First Schedule to the Tree Preservation Order where this is available. You should use the same numbering on your sketch plan (see below for sketch plan requirements).

- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
