Tree 0846 - Lime - repollard
Tree 0847 - Lime - repollard
Reason: Both trees have historically been managed as high pollards at around 10-12m. Regrowth is now due if cyclic regime is to be maintained. Southern lateral growth being complained about by tenants.
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
