				I have experienced the constriction of the footpath's width by the restaurant's external tables and chairs etc because the restaurant currently uses concrete planters to capture the area of the footpath that the proposed structure will capture. Presumably the planters will be placed adjacent to the proposed structure and thus further reducing the width of the remaining footpath.
				This proposed structure along with the retention of the current concrete planters (whose final positions in relation to the structure are not displayed on the planning application) will take up too much of the remaining width of the footpath, constricting the space for pedestrians to pass by one another or be able to walk side by side and will also be an obstacle for wheelchair users forcing them to cross the road in order to pass.
				The Design and Access Statement states that the concrete planters, "will be adjusted as necessary to accommodate any new proposed structure." This is too vague and is proposed to be left to the discretion of the restaurant management. This is unacceptable because there are no controls set by the council regarding the final positioning of these obstacles on the footpath. I have noticed that the plans give measurements of the remaining footpath width to the kerb but the existing lamppost will further reduce the space available which will be compounded by the addition of rubbish sacks awaiting collection as shown in the photographs (sent to Sofie Fieldsend email address) and the restaurant's A-board.
				Furthermore the dragging of the concrete planters by the restaurant staff has left the footpath's paving slabs scratched and gouged as displayed in one of the photos
				The Design and Access Statement states that the structure is required for Covid resilience? How can this be when the structure will include "removable awning fabric sides for colder weather". This will result in an almost completely enclosed space. How can that offer Covid resilience in periods of colder weather when Covid is more prevalent? I suspect that Covid is being used as an excuse to increase the restaurant's customer capacity by extending on to the footpath.
