G1: Group of mature yews: Approximately11.00m: Rear left hand corner. Reduce crowns by approximately 1.50-2.00m all round. General maintenance manage the trees at reasonable dimensions for their location. Improve light levels. General maintenance.
T1: Mature Cherry: Approximately 10.00m: Reduce crown by approximately 1.50-2.00m all round. Thin crown density by approximately 20%. Raise crown by approximately 1.50m. Remove dead wood. Control encroachment over neighbouring property. General maintenance.
T2: Mature Lime: Approximately 19.00m: Right hand boundary: Remove major dead wood throughout crown. General maintenance.
