Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

A mature ash tree, probably 100 years old, in the front garden of 22 North Villas. It is the only tree and lies close to the pavement wall.

About 30 years ago, it was identified as contributing to the subsidence of the house and remedial structural works were undertaken. Advice was given in 1987 by Camden TPO/8791125, case file C/10/46 to maintain a programme of tree crown reduction to prevent further damage by extended tree roots. This work has been done in 1993, 1997, 2001, 2007, 2011 and 2017, with consent granted in each case.

We seek permission to undertake similar crown reduction works now by Thor's Trees, tree surgeons, Enfield, N18 2PP or a similarly qualified tree surgeon if that company is not free to action the works.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
