The principle of development is likely to be considered acceptable, due to the benefits that would arise from co-locating the POS and MHCAS, and the fact the proposals would help facilitate the redevelopment of the PSH site. The proposed internal layout is also considered to be acceptable at this stage, particularly as it is informed by clinical requirements.

The design of the proposed extension to the POS building is considered to be acceptable in terms of its form and siting. Further discussion is required regarding external materials and window design. It may be useful to meet on site to discuss materials.

As part of a formal planning application (and/or further pre-application discussions), further information regarding the following will also be required:

- Tree protection measures for the retained Silver Birch tree
- Landscaping proposals
- Information about patients in Block 4 (length of stay etc.)
