Location: Side of house

1. Ash Tree A large mature specimen, which has recently been reduced to a 22m + framework pollard, there are several stems, which can be viewed at ground level, are subject to woodpecker holes and large cavities, its also noted that there is evidence of Inonotus hispidus which can break down reaction zones and lead to branch failure.

Recommended works to reduce risk of future failure.

Reduce height down by 6m to a new suitable point and sides by 3m-4m to balance framework.

Rear Garden

- 2. Strawberry Tree Carefully and thoughtfully reduce crown all around by 1m to help manage spread and improve form.
- 3. Camelia Reduce new extension growth back to form.
- 4. Hybrid Poplar Remove all epicormic shoots.

Rear Garden of 24 boundary with 26

5. London Plane Reduce branches over hanging garden of 26 by 4m to suitable growth points.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - $\circ\;$ showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
