we are looking to remove this tree due to the damage the tree roots has caused to the boundary wall, Patio and lawn. There are large Roots that have grow up in the lawn and and very clearly growing towards the property of 71 Hillway, N6 6AB there is a risk that if left the property may suffer from subsidence being in close proximity to the tree. the patio is now raised and is becoming a trip hazard along with the wall. Once the tree is removed we are looking at replanting another tree in its place.

- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
