Provender Store and Long Stables Building, Stables Market, Chalk Farm Road, Camden NW1 8AH
Approval of Details in relation to Planning Permission ref: 2021/5031/L

We write on behalf of our client, Camden Market Estate Holdings Limited, enclosing an application to discharge condition 5 of listed building consent ref: 2021/5031/L, dated 30 November 2021, in respect of the Provender Store and Long Stables Building, Stables Market, Chalk Farm Road, Camden NW1 8AH.

## **Background**

On 30 November 2021 listed building consent (ref: 2021/5031/L) was granted in respect of the site for the following development:

"Installation of new wayfinding signage for the Provender Store and Long Stables Building and associated new lighting. Installation of safety equipment to the north elevation of the Provender Store."

Associated planning permission (ref: 2021/5038/P) and advertisement consent (ref: 2021/5117/A) applications were approved for the same works.

## Condition 5

Condition 5 of the listed building consent states:

"Prior to the commencement of the relevant works, a sample of the proposed ghost signage, showing paint colour and finish, shall be provided on site and approved in writing by the local planning authority. The relevant part of the works shall not be carried out otherwise than in accordance with the details thus approved."

Accordingly, sample pictures of the ghost signage have been submitted in support of this application.

The sign writer for the ghost signage 'C-That', has provided the following statement in respect of the methodology for installing the ghost signage age painted lettering. The lettering would be painted using a water-based paint. Following this, only the paint (not the brick work) would be hand



sanded to create the aged effect, without touching any masonry. After distressing the lettering with sandpaper, the surface will be rinsed with clean water.

It is considered that the information provided is sufficient to satisfy this condition and as such the application should be approved.

There is no application fee due for this application, due to this being an approval of detials application for a listed building consent.
