### Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

All of these trees have been reduced before to these specifications. This work should be considered as routine management.

T1) Bay tree by property: Reduce height and width by 50% to provide tidy and compact shape.

T2) Catalpa (Indian Bean tree): Reduce overall crown by up to 2.5 metres / back to previous reduction framework. Retain substantial growth points to retain even and flowing canopy outline.

T3) Walnut tree: Reduce overall crown by up to 2 metres / back to previous reduction framework; retain even and flowing canopy outline.

T4) Apple tree: Lightly reduce and tidy crown by removing crossing branches and any dead and defective branchwood.

T5) Apple tree with significant lean: Reduce overall crown by up to 2 metres to provide a more upright form.

T6) Beech tree: This tree has been heavily reduced before: remove 50% of regrowth back to previous reduction framework.

All cuts will be made strictly to substantial growth points in line with British Standards of Arboriculture (BS3998) to retain the long term health of the trees.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

Where trees are protected by a Tree Preservation Order, please number them as shown in the First Schedule to the Tree Preservation Order where this is available. You should use the same numbering on your sketch plan (see below for sketch plan requirements).

- Tree species
- The number used on the sketch plan; and

e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Your plan needs to show the precise location of the tree(s) in relation to nearby property/roads/boundaries. It should, therefore:

• indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:

- mark and name surrounding roads
  - sketch in buildings, including adjoining properties
  - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - $\circ\;$  marking all trees on the plan, but only numbering those to which you want to carry out work
  - $\circ~$  showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)
