Replacement of stairs to front of the building that run from street level down to the basement flat. Currently the stairs are of soft-wooden construction dated in the past decade or so, and are seriously deteriorated, to the point of being unsafe. Works under this application would consist of removal of the current wooden stairs, any re-screeding of the current lightwell floor as might be needed to make good from current support posts and ensure fall of water towards drainage, making good any fixing holes or similar in the render, installation and painting of metal stairs, painting of masonry coping/parapet in white as per local vernacular.

Works have "started" in the sense that some portion of the existing stairs has been removed due to being unsafe, and the stairs temporarily repaired using similar soft-woods to the parent structure.
