London plane (T5) - reduce in height by approximately 5-6m and reduce lateral spread to correspond. Works to be undertaken to reduce risk of branch failure from Massaria colonisation. Work specified following climbing inspection / deadwooding operation.

London plane (T27) - reduce in height by approximately 5-6m as per image in attached photographic record and reduce lateral spread to correspond. Works to be undertaken to reduce risk of branch failure from Massaria colonisation. Work specified following climbing inspection / deadwooding operation.

- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
