To fell T00233 which is a sycamore on the west side of Highgate Cemetery, next to the boundary with the children's nursery.
Old pollard rot in crown. Top 20% of tree is dead and all new growth is growing towards nursery playground.
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
