1 x Lime (Tilia Cordata) (T3) - Sever stems at base. Reduce entire crown to previous reduction points, (2.5m - 3m regrowth).

FRONT GARDEN: 1 x Cherry Laurel (Prunus Laurocerasus,) & Cypresses (Cupressus) in hedge form (T4) - Trim back top to previous cuts and trim back front face to compact form.
