NO OBJECTION TO SECTION 211 NOTICE OF WORKS TO TREE/S IN A CONSERVATION AREA

Proposed Work:

REAR GARDEN: 1 x Ash (T1) - Reduce crown by 3m on all aspects.

1 x Sycamore (T2) - Reduce height by 2.5m, reduce branches over neighbour's garden by up to 3m, ensuring 2m clearance from building.

1 x Thuja (T4) - Reduce height by 2m.

1 x Mock Orange (T5) - Reduce down to previous cuts, (around 2.5m reduction).

1 x Cherry (T6) - Reduce two leaning stems over grass to 2m below previous, reduce remaining crown back to previous cuts, (1.5m reduction).

1 x Thuja (T7) - Reduce height by 1.5m.

1 x Norway Maple (T8) - Reduce crown back to most recent cuts, (2.5m reduction).

1 x Photinia (T9) - Reduce overlong branches by 2m.

1 x Cherry (T11) - Reduce crown back to previous cuts, (2m reduction).

1 x Apple (T12) - Reduce crown by 3m.

1 x Contorted Willow (T13) - Reduce crown back to previous cuts, (1.5m reduction).

1 x Juniper (T14) - Fell to ground level.

1 x Elder (T15) - Reduce down to 2m.

1 x Sycamore (T16) - Reduce crown by 3m on all aspects.

The Council has considered your notification of intended works to trees dated 30 March 2022 and does not wish to object.

- 1 This notice is valid for 2 years from the date of this letter or until the work is completed, whichever is the sooner.
- 2 You are advised that the appropriate standards for tree work are set out in BS 3998: 2010. Failure to ensure that the proposed works are carried out to these standards may result in damage to the tree(s) and may result in legal action by the Council.
- 3 Please note that any approval given by the Council does not give an exemption from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife.
