T5- Fig tree- crown reduction back to most recent pruning points (up to 2m reduction), leaving furnishing growths.
T1 - quince tree (6m) - reduce crown to previous pruning points, approximately 1.5m reduction, reduce overhang of patio by up 2m and remove clematis from tree.
T2 - birch tree (7m) - remove clematis from tree.
T3 - lilac tree (6m) - reduce height by approximately 1.5m and remove rose from tree.
T4 - apple tree (5m) - reduce crown to previous pruning points, approximately 0.75m reduction.

 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
