T1: Mature Ash: Approximately 21.00m: Thin crown density throughout by approximately 25%. Remove dead wood and broken branches. Reduce crown by approximately 1.50-2.50m by means of reducing overlong extraneous branches back into main crown structure. General maintenance.			
T2: Mature Hornbeam: Approximately 20.00m: Remove dead wood throughout crown. Thin crown density by 20%. Reduce overlong extraneous branches back into main crown structure, Up to 2.50m branch reduction where required. To control height and encroachment over neighbouring properties. General maintenance.
