Proposal:

Replacment of UPVC patio door and windows to ground floor rear elevation and adjustment of existing rooflight to rear extension.

The Council has considered your application and decided to grant permission subject to the following condition(s):

Condition(s) and Reason(s):

1 The development hereby permitted must be begun not later than the end of three years from the date of this permission.

Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).

The development hereby permitted shall be carried out in accordance with the following approved plans 1061 APL 001B; 1061 APL 003B; 1061 ASU 003;

1061 ASU 005; 1061 ASU 006.

Reason:

For the avoidance of doubt and in the interest of proper planning.

All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy D1 and D2 of the London Borough of Camden Local Plan 2017.

Informative(s):

1 Reason for granting:

The existing uPVC patio doors would be replaced with aluminium framed double glazed patio doors at the rear of the property at ground floor level. The existing rooflight on the valley roof of the closet wing would be replaced with a flush rooflight in a higher position on the roofslope.

Whilst the property is located in the Dartmouth Park Conservation Area, the proposed metal frames double glazed patio doors are located at the rear of the property at ground floor level and would not be prominent in public views. The rooflight would be flush and would not appear out of character on this element of the building as it is replacing an existing rooflight in a similar location.

Overall therefore, the proposals are considered to be sympathetic to and in keeping with the existing appearance of the host property in terms of the design, locations, proportions and materials, and would preserve the character and appearance of the building and Dartmouth Park Conservation Area in which it is located, and as such, is acceptable in design terms.

Aluminium is a preferable material to UPVC as it has a lower level of embodied carbon so is acceptable in terms of sustainability.

There are no amenity concerns to neighbouring properties given the proposal would mainly replace existing building features and fenestration.

The site's planning and appeals history has been taken into account when coming to this decision. No objections have been received following statutory consultation. The Dartmouth Park Neighbourhood forum commented with no objection.

Special attention has been paid to the desirability of preserving or enhancing the character or appearance of the South Hampstead Conservation Area, under s.72 of the Planning (Listed Buildings and Conservation Areas) Act 1990 as amended by the Enterprise and Regulatory Reform Act [ERR] 2013.

As such, the proposal is in general accordance with policies A1, CC1, D1 and

D2 of the Camden Local Plan 2017, the London Plan 2021 and the National Planning Policy Framework 2021.
