The Council has considered your application and decided to grant permission subject to the following condition(s):

Condition(s) and Reason(s):

1 The development hereby permitted must be begun not later than the end of three years from the date of this permission.

Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).

The development hereby permitted shall be carried out in accordance with the following approved plans Site Location Plan 17159-L01, PP001, SU001, PX001. Arboricultural Method Statement (Landmark Trees ref: LC/56AVR/AMS/01a).

Reason: For the avoidance of doubt and in the interest of proper planning.

All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy D1 of the London Borough of Camden Local Plan 2017.

4 All work shall be carried out in accordance with the relevant recommendations of British Standard 3998: 2010. (Recommendations for Tree Work)

Reason: To ensure the preservation of the amenity value and health of the tree(s).

Informative(s):

1 Reasons for granting permission:

The proposed installation of metal railings to the side boundary wall is considered acceptable in terms of scale, design and materials. Whilst the wall in question is adjacent to a public highway and footpath, it is not considered that adding additional height to the wall would cause undue harm to the surrounding environment, particularly because there are already mature trees which line the side boundary and the railings would still allow views through.

The impact on the trees is considered to be acceptable. The applicant has provided an arboricultural method statement. The Council's Tree Officer has reviewed the documents and raised no objections.

The proposal is not considered to cause any adverse impacts on the amenity of adjoining residential occupiers in terms of loss of light, privacy or outlook.

No objections have been received prior to making this decision. The planning history of the site has been taken into account when coming to this decision.

As such, the proposed development is in general accordance with policies A1, D1 and D2 of the Camden Local Plan 2017. The proposed development also accords with the London Plan 2021 and the National Planning Policy Framework 2021.

Your proposals may be subject to control under the Building Regulations and/or the London Buildings Acts that cover aspects including fire and emergency escape, access and facilities for people with disabilities and sound insulation between dwellings.
