I have lived in this property for many years. My bedroom is at the rear of the property.</p> <p>I do not believe the report stating that due to the ambient noise around the area and the noise of the trains that I will not be disturbed by the events space.</p> <p>For a number of years, the WCs of the offices space in the arches off Bonny Street have vented onto my property. I have been disturbed by the noise of this vent whilst using my garden and trying to sleep. The Arch Co have agreed to rectify the issue. Given the disturbance cause by a small fresh air vent the idea that 200 people at an event, even without music, will not cause me disturbance is laughable.</p> <p>I am also concerned about the prospect of filming to raise funds. We have had filming in Ivor Street before and agreed that we should avoid it in future as they take over the whole street with trucks, people, and equipment. It is not exciting or interesting. It is inconvenient and disruptive.</p> <p>I am also very concerned about anti-social behaviour as I am unable to find any reference as to how the proposed park will be policed. We have significant drug dealing, drug taking, drinking and teenagers causing noise in the local streets already where they can be seen and reported. How will they be seen and reported when they are on the highline during or after opening hours? How will people be prevented from accessing the highline out of hours? The railway viaduct's potential to restore 4 tracks means that the East London Line extension could be extended from Highbury & Islington to terminate at Camden Road (as originally intended), improving connectivity to Camden from that axis without the requirement for changing trains.
