The Inspector is preparing for this event on the basis that it is to be an in-person event, with the facility to participate virtually if key participants (including the Inspector) are unable to attend due to Covid etc.

Notification

No later than 2 weeks before the opening of the hearing you must serve a notice of the hearing arrangements on those persons other than the appellant(s) with an interest in the land, those who made representations at the application and/or appeal stages, those entitled to appear at the hearing and anyone else you consider to be affected by or interested in the proposed development.

Your letter should cover:

- an Inspector has been appointed by the Secretary of State to determine this appeal;
- that the Hearing is to be held as an in-person event but with the facility to revert to a virtual meeting if necessary;
- the location of the appeal site and a description of the development;
- a link (via the Council's website) to the appeal documents or that the documents can be viewed at the Council offices by prior arrangement;
- that they may attend the hearing and, at the Inspector's discretion, give their views
- that anyone wishing to attend the Hearing should contact the Local Planning Authority as soon as possible prior to the Hearing and provide their email address just in case there is a need to revert to a virtual meeting. (Please include a point of contact at the Council)
- that the decision will be published on https://acp.planninginspectorate.gov.uk/
- what facilities are available for people with disabilities e.g. parking spaces, access and seating arrangements etc.

You should send a copy of this letter and a list of those notified to me. In addition, prior to the hearing, please provide me with a list of those parties who have notified you of their wish to attend, and a link to the virtual back-up meeting.

If you consider it appropriate, please notify the press of the hearing and, if notice of the hearing is published in the press, send a copy of the notice(s) to me.

Please also note that people with disabilities who may be concerned about facilities at the hearing venue have been advised to contact you to confirm that proper provisions are in place.
