Works: Remove (fell) to near ground level and treat stump to inhibit regrowth.

Works: Reduce height by 2m and crown radius by 1m leaving balanced crown. Prune on a triennial cycle to maintain at broadly reduced dimensions.

Reason: Clay shrinkage subsidence damage at 180 Camden Road, NW1 9HG.

Further notifications to be submitted regarding T1 Prunus, T2 Tree of Heaven and T6 Holly of the MWA Arboricultural Report. Previous No Objection Notice has been issued for this work which has expired prior to work having been carried out.
